## **CHAPTER 1**

### **GENERAL PROVISIONS**

#### **ARTICLE 1 . -**

This Prakas aims to define the procedures for the issuance of permit and management of trade, production and mixing of all kinds of animal feeds, raw materials or additives.

#### **ARTICLE 2 . -**

This Prakas aims to:

- Ensure the quality, hygiene, safety, and standards of all kinds of animal feed, raw materials or additives;
- Ensure the effectiveness in the management of importation, exportation, transit, production, mixing, repackaging, stockpiling, supplying, distribution, wholesaling, retailing, transportation, advertisement and professional qualification in trading all kinds of animal feeds, raw materials or additives;
- Protect animal and human health, and animal well-being;
- Protect the interests of consumers and the environment.

#### **ARTICLE 3 . -**

This Prakas applies to all activities related to the issuance of permit and management of trade, production, and mixing of all kinds of animal feeds, raw materials or additives in the Kingdom of Cambodia.

## **CHAPTER 2**

### **PROCEDURES FOR THE GRANT OF PERMIT**

#### **Section 1**

#### **IMPORTATION, EXPORTATION AND TRANSIT**

##### **ARTICLE 4 . -**

Natural persons or legal entities intending to import, export, or transit all kinds of animal feeds, raw materials or additives shall apply for a permit at the General Department of Animal Health and Production.

Natural persons or legal entities applying for a permit for importation, exportation and transit of animal feeds, raw materials, or additives of all kinds shall complete the application form and provide a complete set of documents as required in the application form.

A sample of the application form for the permit importation, exportation and transit of all kinds of animal feeds, raw materials, or additives are set out in Annex 1 of this Prakas.

##### **ARTICLE 5 . -**

The General Department of Animal Health and Production shall review and evaluate the application form of an applicant. In case if it is found that the application dossier is correct and complete in accordance with the procedures, the General Department of Animal Health and Production shall request for the decision principle from the Ministry of Agriculture, Forestry and Fisheries.

Based on the approval principle from the Ministry of Agriculture, Forestry and Fisheries, the General Department of Animal Health and Production shall issue the applicant a permit for importation, exportation and transit of all kinds animal feeds, raw materials or additives.

The process for the review of an application submitted by a natural person or legal entity shall take thirty (30) days from the date of receipt of a complete and correct application.

A sample of the permit for importation, exportation and transit of animal feeds, raw materials, or additives of all kinds are set out in Annex 2 of this Prakas.

##### **ARTICLE 6 . -**

A permit for importation, exportation and transit of all kind of animal feeds, raw materials or additives shall be valid for one (1) year, unless it is revoked or suspended before the expiration date.

## **Section 2**

### **PRODUCTION, MIXING AND RE-PACKAGING**

#### **ARTICLE 7 . -**

Natural persons or legal entities intending to produce, mix, or repackage animal feeds, raw materials or additives of all kinds shall apply for a permit from the General Department of Animal Health and Production.

Natural persons or legal entities applying for a permit to produce, mix, or repackage animal feeds, raw materials or additives of all kinds shall complete the application form and provide a complete set of documents as required in the application form.

A sample of the application form for the permit for the production, mixing or re-packaging of animal feeds, raw materials or additives of all kinds are set out in Annex 3 of this Prakas.

#### **ARTICLE 8 . -**

The General Department of Animal Health and Production shall review and evaluate the applicant's file and assign the Animal Health and Production Inspector to inspect and evaluate the location and processes of production, mixing or re-packaging. In case where the application is correct and complete in accordance with the procedures and concrete reports of the Animal Health and Production Inspector, the General Department of Animal Health and Production shall request a decision principle from the Ministry of Agriculture, Forestry and Fisheries.

Based on the approval principle from the Ministry of Agriculture, Forestry and Fisheries, the General Department of Animal Health and Production shall issue the applicant the permit for production, mixing or re-packaging of animal feeds, raw materials or additives of all kinds.

The process for the review of an application submitted by a natural person or legal entity shall take forty-five (45) days from the date of receipt of a complete and correct application.

A sample of the permit for production, mixing or re-packaging of animal feeds, raw materials or additives of all kinds are set out in Annex 5 of this Prakas.

#### **ARTICLE 9 . -**

A permit for production, mixing or re-packaging of animal feeds, raw materials or additives of all kinds shall be valid for five (5) years, unless it is revoked or suspended before the expiration date.

Natural persons or legal entities shall apply for renewal of the permit for production, mixing or re-packaging of animal feeds, raw materials or additives of all kinds not less than six (6) months before the expiration date for the General Department of Health Animals and Production to review and re-evaluate.

The sample of the application form for renewal of the permit for the production, mixing or re-packaging of animal feeds, raw materials or additives of all kinds are set out in Annex 4 of this Prakas.

### **Section 3**

#### **STOCKPILLING**

##### **ARTICLE 10 . -**

Natural persons or legal entities that import, export, produce, mix, repackage and supply or distribute all kinds of animal feed, raw materials or additives in the Kingdom of Cambodia shall have warehouses. The natural persons or legal entities shall apply for a warehouse registration certificate from the General Department of Animal Health and Production.

Natural persons or legal entities applying for a warehouse registration certificates for stockpiling animal feeds, raw materials or additives of all kinds shall complete the application form and provide a complete set of documents as required in the application form in accordance with the procedures for registration.

The General Department of Animal Health and Production shall assign an Animal Health and Production Inspector to inspect and evaluate the location of the requested warehouse in accordance with the procedures for registration.

A sample of the application form for the warehouse registration certificate for stockpiling of animal feeds, raw materials or additives of all kinds for supply and distribution in the Kingdom of Cambodia is set out in Annex 6 of this Prakas.

##### **ARTICLE 11 . -**

The General Department of Animal Health and Production shall review and evaluate the application form of an applicant. In case the application is correct and complete, in line with the inspection and evaluation report of the competent Animal Health and Production Inspector, in accordance with the technical standards and procedures for registration, the General Department of Animal Health and Production shall issue a warehouse registration certificate for stockpiling animal feeds, raw materials or additives of all kinds to the applicant.

The process for the review of an application submitted by a natural person or legal entity shall take forty-five (45) days from the date of receipt of a complete and correct application.

A sample of the warehouse registration certificate for stockpiling animal feeds, raw materials or additives of all kinds for supply and distribution in the Kingdom of Cambodia is set out in Annex 7 of this Prakas.

##### **ARTICLE 12 . -**

A warehouse registration certificate for stockpiling animal feeds, raw materials or additives of all kinds for supply and distribution in the Kingdom of Cambodia shall be valid for five (5) years, unless it is revoked or suspended before the expiration date.

Natural persons or legal entities shall apply for renewal of the warehouse registration certificates for stockpiling animal feeds, raw materials or additives of all kinds at least three (3) months before the expiration dates.

##### **ARTICLE 13 . -**

Natural persons or legal entities intending to supply- distribute animal feeds, raw materials or additives of all kinds in the municipalities/provinces shall have a warehouse. Natural persons or legal entities shall apply for the warehouse registration certificate at the Office of Animal Health and Production of the concerned Municipal/Provincial Department of Agriculture, Forestry and Fisheries.

Natural persons or legal entities applying for the warehouse registration certificate for stockpiling animal feeds, raw materials or additives of all kinds shall complete the application form and provide a correct and complete set of documents as required in the application form.

The Office of Production and Veterinary shall request its respective Municipal/Provincial Department of Agriculture, Forestry and Fisheries to assign a competent Animal Health and Production Inspector to inspect and evaluate the location of the requested warehouse in accordance with the procedures for registration.

A sample of the application form for the warehouse registration certificate for stockpiling animal feeds, raw materials or additives of all kinds for supply-distribution in the municipalities and provinces is set out in Annex 8 of this Prakas.

#### **ARTICLE 14 . -**

The Municipal/Provincial Office of Production and Veterinary shall review and evaluate the application filed by the applicant. In case where the application is correct and complete, in line with the warehouse location evaluation report by the competent Animal Health and Production Inspector, in accordance with the technical standards and procedures, the Municipal/Provincial Office of Production and Veterinary shall request for decision principle from its respective Municipal/Provincial Department of Agriculture, Forestry and Fisheries.

Based on the approval principle of the Municipal/Provincial Department of Agriculture, Forestry and Fisheries, the relevant Municipal/Provincial Office of Production and Veterinary shall issue a warehouse registration certificate for stockpiling animal feeds, raw materials, or additives, with a serial number provided by the Municipal/Provincial Department of Agriculture, Forestry and Fisheries.

The process for the review of an application submitted by a natural person or legal entity shall take forty-five (45) days from the date of receipt of a complete and correct application.

The sample of the warehouse registration certificate for stockpiling animal feeds, raw materials or additives of all kinds for supplies and distribution in the municipal/provincial territories is set out in Annex 9 of this Prakas.

#### **ARTICLE 15 . -**

A warehouse registration certificate for stockpiling animal feeds, raw materials or additives of all kinds for supply and distribution in the municipal/provincial territories shall be valid for five (5) years, unless it is revoked or suspended before the expiration date.

Natural persons or legal entities shall apply for renewal of the warehouse registration certificates for stockpiling animal feeds, raw materials or additives of all kinds no less than three (3) months before the expiration dates.

## **Section 4**

### **Supply, DISTRIBUTION AND WHOLESALE/RETAIL**

#### **ARTICLE 16 . -**

Natural persons or legal entities intending to supply and distribute animal feeds, raw materials or additives of all kinds in the municipalities or provinces of the Kingdom of Cambodia shall apply for a permit for supply and distribution from the General Department of Animal Health and Production.

Natural persons or legal entities applying for permit for supply and distribution of animal feeds, raw materials or additives of all kinds shall complete the application form and provide a complete set of documents as required in the application form.

A sample of the application form for the permit for supply and distribution of animal feeds, raw materials or additives of all kinds is set out in Annex 10 of this Prakas.

#### **ARTICLE 17 . -**

The General Department of Animal Health and Production shall review and evaluate the filed application of an applicant. In case where the application is correct and complete in accordance with the procedures, the General Department of Animal Health and Production shall issue a permit for supply and distribution of animal feeds, raw materials or additives of all kinds, to the applicant.

The process for the review of a filed application shall take thirty (30) days from the date of receipt of a complete and correct application form.

A sample of the permit for supply and distribution of animal feeds, raw materials or additives of all kinds is set out in Annex 11 of this Prakas.

#### **ARTICLE 18 . -**

A permit for supply and distribution of animal feeds, raw materials or additives of all kinds shall be valid for one (1) year, unless it is revoked or suspended before the expiration date.

#### **ARTICLE 19 . -**

Natural persons or legal entities intending to wholesale or retail animal feeds, raw materials or additives of all kinds in the municipalities or provinces shall apply for a permit to wholesale-retail at the Office of Animal Health and Production of the concerned Municipal/Provincial Department of Agriculture, Forestry and Fisheries.

Natural persons or legal entities applying for a permit to wholesale-retail animal feeds, raw materials or additives of all kinds shall complete the application form and provide a correct and complete set of documents as required in the application form.

A sample of the application form for the permit to wholesale/retail of animal feeds, raw materials or additives of all kinds is set out in Annex 12 of this Prakas.

#### **ARTICLE 20 . -**

The Office of Production and Veterinary of the Municipal/Provincial Department of Agriculture, Forestry and Fisheries shall review and evaluate a filed application of an applicant. In case where the application dossier is correct and complete in accordance with the procedures, the Office of Production and Veterinary shall make a request for a decision principle from its respective Municipal/Provincial Department of Agriculture, Forestry and Fisheries.

Based on the approval principle of the Municipal /Provincial Department of Agriculture, Forestry and Fisheries, the concerned Municipal Provincial Office of Production and Veterinary shall issue a permit to wholesale-retail animal feeds, raw materials or additives of all kinds, with a serial number provided by Municipal/Provincial Department of Agriculture, Forestry and Fisheries, to the applicant.

The process for the review of an application submitted by a natural person or legal entity shall take thirty (30) days from the date of receipt of a complete and correct application form.

A sample of the permit to wholesale-retail animal feeds, raw materials or additives of all kinds is set out in Annex 13 of this Prakas.

#### **ARTICLE 21 . -**

A permit to wholesale-retail animal feeds, raw materials or additives of all kinds shall be valid for one (1) year, unless it is revoked or suspended before the expiration date.

### **CHAPTER 3**

#### **PROCEDURES FOR THE MANAGEMENT OF TRADE, PRODUCTION AND MIXING OF ANIMAL FEEDS, RAW MATERIALS OR ADDITIVES**

##### **Section 1**

#### **IMPORTATION AND EXPORTATION**

#### **ARTICLE 22 . -**

Natural persons or legal entities engaged in the operation of importing or exporting animal feeds, raw materials or additives of all kinds shall comply with each of the following technical standard requirements:

1. Shall possess a permit to import-export;
2. Shall possess a registration certificate for of animal feed, raw materials or additives of all kinds;
3. Shall possess certificate of quality analysis from the country / factory of origin;
4. Shall possess a list of names of animal feeds, raw materials or additives of all kinds from the country / factory of origin for import and export;

5. Shall possess a warehouse registered by the General Department of Animal Health and Production for stockpiling animal feeds, raw materials or all kinds of additives;
6. Shall have technical staff with a bachelor or higher degree in animal science or equivalent recognized by the Ministry of Agriculture, Forestry and Fisheries;
7. Shall ensure safety of the transportation of animal feeds, raw materials or additives of all kinds in accordance with the requirements stated in Article 28 of this Prakas;
8. Shall have a contract on importation-exportation signed between the concerned natural person or legal entity and the General Department of Animal Health and Production.
9. Shall submit a declaration to the General Department of Animal Health and Production for review by an assigned competent Animal Health and Production Inspector .

## **Section 2**

### **TRANSIT**

#### **ARTICLE 23 . -**

Natural persons or legal entities engaged in the operation of transiting animal feeds, raw materials or additives of all kinds shall comply with each of the following technical standard requirements:

1. Shall possess a permit for transit;
2. Shall possess a list of names of animal feeds, raw materials or additives of all kinds for transit from the country of origin.
3. Shall have a contract on transit of animal feeds, raw materials or additives, signed between the concerned natural person or legal entity and the General Department of Animal Health and Production.
4. Shall ensure safety of transportation of animal feeds, raw materials or additives of all kinds in accordance with the requirements as stated in 1, 2, 3, 4 and 7 of the Article 28 of this Prakas and shall ensure that the safety seal is not broken.

## **Section 3**

### **PRODUCTION AND MIXING**

#### **ARTICLE 24 . -**

Natural persons or legal entities engaging in the production and mixing of animal feeds, raw materials or additives of all kinds shall comply with each of the following technical standard requirements:

1. Shall possess a permit for production and mixing of animal feeds, raw materials or additives of all kinds;

2. Shall possess a certificate of registration of animal feeds, raw materials or additives of all kinds;
3. Shall comply with the standard requirements of the registered animal feed, raw materials or additives of all kinds;
4. Shall fully comply with technical standards, ensure the quality and safety in the production and mixing of animal feeds, raw materials or additives of all kinds;
5. Shall have a product description in Khmer, specifying the trade name, common name, registration number of the product, components and composition doses, dosage and method of use, care, storage, effects, prohibition of use, manufacturing and expiry dates of animal feeds, raw materials or additives of all kinds;
6. Shall have a trade name, common name, registration number, source or country of manufacture, lot number, date of manufacture and expiration, usage in Khmer on the packages of animal feeds, raw materials or additives of all kinds.
7. Shall have a design of the production chain and a name list of materials and equipment employed in the production and mixing of animal feeds, raw materials or additives of all kinds;
8. Shall have an organizational chart of the establishment producing or mixing of animal feeds, raw materials or additives of all kinds;
9. Shall have technical staff with a bachelor or higher degree in animal science or equivalent recognized by the Ministry of Agriculture, Forestry and Fisheries;
10. All activities of production and mixing animal feed, raw materials or additives of all kinds shall be under the supervision and responsibility of technical staff;
11. Shall have the original list, trademarks, service marks, trade names or the authorization letter of the manufacturer, if any.
12. Shall have necessary plans and measures for risk management at the place of production and mixing of animal feeds, raw materials or additives of all kinds;
13. Establishments producing or mixing animal feeds shall have operation and control systems that ensure the quality, efficiency and safety of animal feeds, raw materials or additives of all kinds;
14. Shall submit a declaration to the General Department of Animal Health and Production for assignment of a competent animal health and production inspector to review.

#### **Section 4**

### **REPACKAGING**

#### **ARTICLE 25 . -**

Natural persons or legal entities engaging in the repackaging of animal feeds, raw materials or additives of all kinds shall comply with each of the following technical standard requirements:

1. Shall possess a permit for repackaging of animal feeds, raw materials or additives of all kinds;
2. Shall possess a certificate of registration of animal feeds, raw materials or additives of all kinds;
3. Shall comply with the standard requirements of the registered animal feeds, raw materials or additives of all kinds;
4. Shall fully comply with technical standards, ensure the quality and safety of the packaging and re-packaging of animal feeds, raw materials or additives of all kinds;
5. Shall have a product description in Khmer, specifying the trade name, common name, registration number, origin of the product, components and composition doses, dosage and method of use, care, storage, effects, prohibition of use, manufacturing and expiry dates of animal feeds, raw materials or additives of all kinds;
6. There shall be a trade name, common name, registration number, source or country of manufacture, lot number, date of manufacture and expiration, usage in Khmer on the packages of animal feeds, raw materials or additives of all kinds;
7. Shall have a list of names of materials, equipment employed in the re-packaging of animal feeds, raw materials or additives of all kind;
8. Shall have an organizational chart of the establishment that repackages animal feeds, raw materials or additives of all kinds;
9. Shall have technical staff holding a bachelor or higher degree in animal science or equivalent recognized by the Ministry of Agriculture, Forestry and Fisheries;
10. All activities of repackaging of animal feeds, raw materials or additives of all kinds shall be under the supervision and responsibility of technical staff;
11. Shall have the original list, trademarks, service marks, trade name or the authorization letter of the manufacturer, if any;
12. Shall have necessary plans and measures for risk management at the establishments that repackage animal feeds, raw materials or additives of all kinds;
13. Establishments that repackage animal feeds shall have operation and control systems that ensures the quality, efficiency and safety of animal feeds, raw materials or additives of all kinds;
14. Shall submit a declaration to the General Department of Animal Health and Production for it to assign a competent animal health and production inspector to undertake inspection.

## **PART 5**

### **STOCKPILING**

#### **ARTICLE 26 . -**

Natural persons or legal entities that stockpile animal feeds, raw materials or additives of all kinds shall comply with each of the following technical standard requirements:

1. Shall possess a warehouse registration certificate;
2. Shall possess a certificate of registration of animal feeds, raw materials or additives of all kinds;
3. Shall possess a permit for importation, a permit for production, mixing or repackaging of animal feeds, raw materials or additives of all kinds;
4. There shall be a safety system for stockpiling of animal feeds, raw materials or additives of all kinds, such as warehouse maintenance measures, leakage prevention measures, emergency measures; arrangements by specifications, lots, and piles; and safety measures for expired animal feeds, raw materials or additives;
5. The stock warehouses shall be separated from residential area and work office.
6. There shall be sufficient storing shelves and cooling systems to maintain the temperature in the warehouse in accordance with the technical specifications.
7. Shall have on-duty staff who are trained in animal feeds, raw materials or additives of all kinds;
8. Shall have a record book to record all operations related to animal feeds, raw materials or additives of all kinds as stated in the guidelines on the introduction and implementation of the Record Book of Veterinary Medicines and Animal Feeds of the Ministry of Agriculture, Forestry and Fisheries;
9. To submit a declaration to a specialized entity in charge of production and veterinary for assignment of a competent animal health and production inspector to review.

## **Section 6**

### **SUPPLY-DISTRIBUTION AND WHOLESALE-RETAIL**

#### **ARTICLE 27 . -**

Natural persons or legal entities engaged in the supply-distribution and wholesale-retail of animal feeds, raw materials or additives of all kinds shall comply with each of the following technical standard requirements:

- 1 Shall possess a license for supplies, distribution and wholesales/retails of animal feeds, raw materials or additives of all kinds;
2. Shall have a certificate of registration of animal feeds, raw materials or additives of all kinds;
3. Shall have a certificate of completion of vocational education for suppliers-distributors and wholesalers-retailers of animal feeds, raw materials or additives of all kinds;

4. shall be prohibited the supply, distribution or wholesale/retail of animal feeds, raw materials or additives of any kind, either not registered or registered without having the registration number or omission of the registration number on the information label or packaging;
5. Shall be prohibited the supply, distribution or wholesale/retail of animal feeds, raw materials or additives of any kind that are registered under the conditions or permits for usage in experiments;
6. shall be prohibited a display for sale of animal feeds, raw materials or additives of all kinds with food and other goods;
7. Shall be prohibited a sales of animal feeds, raw materials or additives of any kind that are counterfeit, ineffective, defective, or expired;
8. Shall have a place for display or storage as technically required in accordance with the information description or instructions on the display for sale of animal feeds, raw materials or additives of all kinds.

## **Section 7**

### **TRANSPORTATION**

#### **ARTICLE 28 . -**

Natural persons or legal entities transporting animal feeds, raw materials or additives of all kinds shall comply with each of the following technical standard requirements:

1. Shall use transportation mean that ensure the quality and safety of animal feeds, raw materials or additives are not affected;
2. Shall have necessary measures for dealing with any incidents during transportation, and loading and unloading;
3. Shall have a report on transportation and on any irregular activities or incidents that may affect the quality, safety and public health;
4. Shall have a list of names of animal feeds, raw materials or additives of all kinds that are allowed to be transported and stored according to each category for the convenience of the officers of the competent entity in charge of production and veterinary to review;
5. Shall ensure the safety during the transfer of animal feeds, raw materials or additives of all kinds in accordance with technical standards and guidelines;
6. Shall transport animal feeds, raw materials or additives of all kinds by means that ensure that the package of the product is secure, weather-resistant, and does not result to any change in the product's physical and chemical properties, and easy for trading and consumption;
7. Shall be prohibited any transportation of animal feeds, raw materials or all kinds of additives together with food and other goods.

#### **ARTICLE 29 . -**

Natural persons or legal entities intending to transport or circulate animal feed, raw materials or additives of all kinds for domestic supply and distribution shall comply with the technical standards of transportation of animal feeds, raw materials or additives of all kinds and possess a permit for supplies and distribution in accordance with the procedures of the Law on Animal Health and Production and the relevant documents that define the types, quantities and sites, or establishments that accepts the supplies or distribution for a competent Animal Health And Production Inspector to review.

## **Section 8**

### **PUBLICATION AND ADVERTISEMENT**

#### **ARTICLE 30 . -**

Natural persons or legal entities intending to advertise or publish animal feeds, raw materials and additives of all kinds shall file application for prior approval for the publication and advertisement on animal feeds, raw materials and additives in accordance with the provisions and procedures of the Law on Animal Health and Production.

Publications, printed materials, audio-visual materials, presentations, technical guidance for dissemination workshops, technical documents for demonstration experiments or other documents for advertising animal feed, raw materials and all kinds of additives shall be approved in advance by the General Department of Animal Health and Production.

#### **ARTICLE 31 . -**

Natural persons or legal entities shall apply for approval for dissemination or advertisement of animal feeds, raw materials and additives of all kinds from the General Department of Animal Health and Production of the Ministry of Agriculture, Forestry and Fisheries at least thirty (30) days before the implementation date of such dissemination or advertisement.

The application for approval for dissemination or advertisement of animal feeds, raw materials and additives of all kinds shall be accompanied by the company's annual advertisement plan, which specifies the dates and sites of the disseminations advertisements, workshops or demonstration experiments together with technical materials or documents to be used in dissemination for the General Department of Animal Health and Production to review or make necessary adjustments in accordance with the technical aspects and legal procedures in force.

#### **ARTICLE 32 . -**

Articles advertising animal feeds, raw materials and all kinds of additives are required to consist of the followings:

1. Technical content in accordance with the guidelines as defined by the General Department of Animal Health and Production;
2. Compliance with the information or data, defined in the information label or in line with the technical documentation of animal feeds, raw materials and additives of all kinds, attached and stated at the time of registration;
3. Minimum descriptions as follows:

- Identity of animal feeds, raw materials and additives, including trade names, generic names, trademarks and related physical forms;
- Identity of company holding registration, registration number, country and company of origin of production, mixing, importation, exportation, supply, distribution or repackaging
- Method of use;
- Quality, safety and efficacy of animal feeds, raw materials and additives of all kinds
- Guiding customers to read the instructions on the information label in Khmer on the packaging before use.

#### **ARTICLE 33 . -**

Upon obtention of the approval for efficacy publishing and advertising on animal feeds, raw materials and additives of all kinds, natural persons or legal entities shall have the right to advertise in the media and implement their dissemination programs or advertisements of animal feeds, raw materials and additives of all kinds in the municipalities and provinces through notification to the Department of Agriculture, Forestry and Fisheries for cooperation.

### **Section 9**

#### **COMPLETION OF VOCATIONAL EDUCATION**

#### **ARTICLE 34 . -**

Suppliers, distributors or wholesalers-retailers of animal feeds, raw materials and additives of all kinds shall have a certificate of vocational education to meet the prerequisites for applying for a permit for supply, distribution or wholesale/retail.

Suppliers/distributors of animal feeds, raw materials and additives of all kinds shall apply for the vocational education in their operations from the General Department of Animal Health and Production.

Wholesalers-retailers of animal feeds, raw materials and additives of all kinds shall apply for the vocational education in their operations from the Office of Production and Veterinary of the concerned Municipal/Provincial Department of Agriculture, Forestry and Fisheries.

The Office of Production and Veterinary of the concerned Municipal/Provincial Department of Agriculture, Forestry and Fisheries shall request the General Department of Animal Health and Production for collaboration in the organization of the vocational training and issuance of vocational education certificates.

#### **ARTICLE 35 . -**

The General Department of Animal Health and Production and the Production and Veterinary Office of the Municipal/Provincial Department of Agriculture, Forestry and Fisheries are responsible for the preparation of education programs and providing services in the implementation of vocational of education programs in the trade of animal feeds, raw materials, and additives of all kinds within their respective jurisdiction.

## **Section 10**

### **RECOGNITION OF TECHNICAL STAFF**

#### **ARTICLE 36 . -**

On duty technical staff at establishments that import, export, produce, mix and repackage animal feeds, raw materials and additives shall meet the following criteria to be recognised by the General Department of Animal Health and Production:

1. Possess a bachelor or higher degree in animal health and production, or veterinary science, or equivalent recognized by the Ministry of Agriculture, Forestry and Fisheries;
2. Possess a certificate of completion of vocational education issued by the General Department of Animal Health and Production.

In case of termination or change of technical staff, establishments that import, export, produce, mix, repackage animal feeds, raw materials and additives shall report to the General Department of Animal Health and Production to request for the recognition of new technical staff.

## **Section 11**

### **GENERAL RULES AND OBLIGATIONS OF LICENSE HOLDERS**

#### **ARTICLE 37 . -**

Natural persons or legal entities that hold permit or certificates for the operations related to animal feeds, raw materials and additives of all kinds shall perform the following obligations:

- Shall display permit or certificates for related operations in their establishments or places of business;
- Shall report or provide information to concerned local entity in charge of animal health and production on the harms or effects caused by animal feeds, raw materials and additives of all kinds;
- Shall declare the types, specifications, and quantities of animal feeds, raw materials and additives of all kinds that are traded, produced or mixed and shall keep records in the record book for all related operations;
- Shall maintain a hygienic condition in its production and business premises;
- Shall implement training programs on safety rules in all related operations and equip personal safety protection tools for the staff members directly involved with the operations;
- Shall define and implement technical standards for the use and maintenance of equipment employed with animal feeds, raw materials and additives of all kinds, and safety protection tools;
- Shall implement regular health monitoring and care programs for staff members directly involved with animal feeds, raw materials and additives of all kinds;

- In case of non-compliance with the defined standard requirements or technical standards or potential risks to animal and human health and environment, the animal feeds, raw materials and additives of all kinds shall be recalled and stored to control the risks as necessary, and all related expenses shall be covered by the concerned establishments;
- Perform other duties as stipulated in the provisions and procedures of the Law on Animal Health and Production and other applicable legal documents.

#### **ARTICLE 38 . -**

Companies that import, export, produce, mix, repack, stockpile or supply or distribute all kinds of animal feeds, raw materials and additives in the Kingdom of Cambodia shall display related permit or certificates in their establishments and shall keep documents or certificates specifying the registered types of the animal feeds, raw materials and additives of all kinds being traded.

Wholesalers/retailers of animal feeds, raw materials and additives of all kinds in the municipalities and provinces shall display in their booths the relevant permits or certificates and shall keep the documents or certificates of registration of the animal feeds, raw materials and additives all kinds, with registration number.

### **Section 12**

#### **RECORD BOOK**

#### **ARTICLE 39 . -**

Establishments carrying out operations related to animal feeds, raw materials and additives of all kinds shall have a record book for each operation in accordance with the guidelines for the introduction and implementation of a record book for all operations related to veterinary medicines and animal feeds of Ministry of Agriculture, Forestry and Fisheries, defined by the General Department of Animal Health and Production.

### **CHAPTER 4**

#### **OBLIGATIONS TO PAY PUBLIC SERVICE FEES**

#### **ARTICLE 40 . -**

Natural persons or legal entities applying for permit or certificates related to importation, exportation, transit, production, mixing, repackaging, stockpiling, supply, distribution, wholesale-retail, completion of vocation education, recognition of technical staff in their establishments, publications, or advisements of animal feeds, raw materials or additives of all kinds are obliged to pay the public service fees to the National Budget in accordance with the inter-ministerial Prakas on the Provision of Public Services by the Minister of Economy and Finance and the Minister of Agriculture, Forestry and Fisheries.

### **CHAPTER 5**

## **FINAL PROVISIONS**

### **ARTICLE 41 . -**

Any provisions that are contrary to this Prakas shall be considered as null and void.

### **ARTICLE 42 . -**

The Secretary General, the Inspector General, the Director General of the General Department of Animal Health and Production, the Director of the Department of Agricultural Legislation, the chiefs of all relevant units under the Ministry of Agriculture, Forestry and Fisheries, and the Directors of the Capital/Provincial Departments of Agriculture, Forestry and Fisheries shall be responsible for implementing this Prakas according to their respective duties from the date of signature.
